## IV. PUBLIC PARTICIPATION -

- C.J. Bergamo, sophomore student at LMHS, class president, presented to the Board 5 petitions containing a total of 140 student signatures petitioning to keep teachers from being cut from the budget; pass the budget with no cuts; improve the quality of education; the cuts in certified teaching staff will have effects on accreditation in 2013.
- Suzanne Yeo, resident and retired teacher in Lebanon, expressed concerns with the school budget cuts, reinstatement of the $\$ 300,000$, and make the decisions on the budget reduction items public information.
- Heidi Tarbox, resident, questioned if the Board and/or the Superintendent had heard about the emergency funding to towns for schools by the State Legislature. Mr. McGray stated that he was not aware but this maybe on the federal level.
- Miguel Garcia, former LEA president, Spanish teacher at LMHS, expressed concerns on the loss of certified staff; cutting extracurricular activities to retain certified staff and consider a balance of needs of this important piece.
- Kathleen Smith, resident, mother of 3, LES teacher, expressed the importance of keeping extracurricular activities to fulfill college requirements.
- Ellen Turner, LES art teacher, past president of LEA, expressed concerns on the lack of documentation of team leaders, department heads, the loss of these and the importance of these to be made available.

2. Finance/Budget - The subcommittee has brought to the full Board the list of budget final reductions. Discussion will be opened to Board members on these reductions. L. Jahoda looked at the impacts to students and wants alternatives to the reductions that have been presented. Would like to look at extracurricular activities before losing a teacher. S. Tremblay stated her unhappiness with the budget reduction list and would like to see pay-to-play at the high school and elimination of middle school sports, and a need to retain the guidance and history positions at the high school. D. Skaats reviewed the least important items which included: elimination of clubs, field trips - have programs come to the schools, and to retain the guidance position at the high school. D. Kokoszka expressed disappointment in the budget reduction list, the $0 \%$ budget, look to the future at changing the process, increase further negotiations with the Town Board of Finance. M. Hofmann would like to see pay to participate for sports and extracurricular activities. J. Mello encouraged Board members to consider the work done by
administration in preparing the list of reductions and to give direction to administration to meet Friday/Monday deadlines. The Board provided the following to the Superintendent to review more closely: 1) reinstate guidance position; 2) eliminate science enrichment at LES; 3) reinstate .4 P.E. LMS) elimination of extracurricular activities, including clubs and eliminate middle school sports and have pay-to-play at the high school.
