- Kathleen Smith resident, parent, 4th grade teacher at LES expressed support of the Science & Technology Enrichment program and the position at the Elementary School; the Board should look at refinance bonding projects to save money.
- Blake Smith Middle School student asked the Board not to take away educational programs; the French/Spanish program at the Middle School; more options for athletics at the middle school, specifically for 6th grade students.
- Mrs. Solari teacher at the Elementary School, expressed the importance of Science/Technology education; classroom size at the high school; elimination of the French/Spanish program at the middle school; class size the elementary school and the need to keep small classroom size and the impacts this has on children.
- Ron Cowles, resident, expressed concerns on the future education of students and the need for concessions by teachers to keep programs.
