#### **REGULAR MEETING**

December 6, 2016– 3:00 PM Town Hall

## **MINUTES**

Members present: First Selectman Betsy Petrie, Selectman Glen Coutu, and Selectman John Bendoraitis

**Others present:** LVFD President Mark Elliot, Town Planner Philip Chester, Highway Foreman Jay Tuttle, Public Works Building Committee (PWBC) Chair Rob Cady, Jim Hallene, and Administrative Assistant Linda McDonald

- **1.0 Call to Order:** B. Petrie called the meeting to order at 3:00 p.m.
- **2.0 Public Forum:** M. Elliott informed the board on the possible opportunity to purchase a 75' ladder truck from the Town of Pomfret. M. Elliot reported that the LVFD applied for a grant to get funds for a new truck and the department should know if Lebanon was awarded grant in March or April 2017. Time might be an issue as the Town of Pomfret would entertain bids by early next year. The current truck does have resale value.
  - G. Coutu MOVED to discuss item 6.1 at this point of the meeting. J. Bendoraitis SECONDED. MOTION CARRIED 3:0:0.

#### 6.0 Old Business

- **6.1** Discuss and act upon update from the Public Works Building Committee:
  - R. Cady reported the PWBC had a special meeting on 11/22/16 to review new plans on the middle school property as a possible location for new public works building. The test pits looked positive. The PWBC voted, at that meeting, to proceed with that site as the first preference. Anchor Engineering will develop a budget for the public works facility, and have it include as separate items, school bus parking consideration and demolition and environmental cleanup at current location of public works. The next meeting of the PWBC is scheduled for 12/13/16.
  - B. Petrie said she has concern with price tag for the project but is encouraged that an existing piece of town property can be utilized and access onto a major highway is a positive. She said she would encourage the PWBC to get to a price point that will pass at town meeting. B. Petrie reported that the plan to locate the facility on the middle school property was favorably received at a recent Board of Education (BOE) meeting,
  - P. Chester presented preliminary plans for a re-design for a smaller facility based on requirements of public works equipment. This plan has not yet reviewed by PWBC members or the schools Facilities Director.
  - J. Bendoraitis suggested situating the proposed building with a more southerly exposure to make use of solar panels.

Discussion followed on sizes and uses of the cold storage and heated areas in the proposed building.

Consensus of the BOS was to warn a special meeting on December 15, 2016 to discuss and possibly act upon support for the proposed facility, dependent upon receipt of a cost estimate for the project from the PWBC.

R. Cady reported that Anchor Engineering will have remediation testing done at the current public works facility site and would provide results and associated remediation costs in January 2017.

Discussion followed on looking at possible grant funding for the project.
