The Board reviewed the language to call the Special Town meeting for vote by the town residents on the ordinance titled "An Ordinance Dissolving the Board of Historical Preservation for the Jonathan Trumbull Jr. House Museum and Designation of the Board Members of the Jonathan Trumbull JR. House Museum LLC". The purpose of this ordinance is to enable the Trumbull Jr. House Museum to continue to receive annual grant funds from the Adams Family Trust. The Trust has specific restrictions that require funds to only go to LLCs or not-for-profits. The new ordinance will allow the creation of an LLC permitting the Lebanon Historical Society to be the holder of the LLC with one of the Board appointees coming from the LHS. The LHS has been working for the past year with attorneys from the Adams Trust and town attorneys with the First Selectman to bring about this process.
