Board of Selectmen Special Meeting October 30, 2014 – 9:00 AM Town Hall MINUTES

Meeting was called to order at 9:05 AM by First Selectman Joyce Okonuk. Selectmen Linda Finelli and John Bendoraitis were present. Audience: 1

1.0 Selectmen opened bids for Cemetery Mowing and Maintenance as follows:

Motion by Finelli/Bendoraitis to award the harvesting of hay at multiple sites in Lebanon to Cushman Farms, Franklin in the amount of \$1,430 per year in 2015 and 2016. Vote: Yes, unanimous

4.0 Motion Finelli/Bendoraitis to rescind the motion made under 4.0 in the minutes of the Special Selectmen's Meeting on October 16, 2014. Vote: Yes, unanimous

At the request of Selectmen at the 10/16/14 meeting, Public Works Director Brandon Handfield researched costs associated with a two year maintenance and certification on the newly purchased bucket truck.

Motion Bendoraitis/Finelli to authorize the purchase of a 2001 International Model 4700 Bucket Truck with 42' boom from Nutmeg International in the amount of \$23,912 including a two year maintenance and bucket certification, funds to come from Capital Budget Account #220-00-430-2782-0030-0000. Vote: Yes, unanimous

- **5.0** First Selectman Okonuk has been working with Planner Phil Chester and Town Engineer Brandon Handfield to develop a conceptual layout and criteria for the development of age-restricted housing on town-owned property adjacent to the Senior Center. They met with the Planning & Zoning Commission who is amendable to this proposal. Language is being developed for the Request for Proposals which will be reviewed by both the Selectmen and PZC prior to publication. Several letters of interest from present and former Lebanon residents for this type of housing have been received in the Selectman's Office.
- **6.0** Proposal have been received from the appliance vendor for the replacement of the stove at the FSC kitchen (public side). Options include the choice of electric or propane and Selectmen want the First Selectman to obtain costs for the installation of gas to the proposed unit and the change in electrical outlet that may be required should the stove be converted from electric to gas. No further action until that information is received.
- 7.0 As requested, the Walker Group submitted a proposal for the Selectmen's review.

 Motion by Bendoraitis/Finelli to renew a one-year contract with The Walker Group for server maintenance and desktop support in the amount of \$12,048.00, effective November 1, 2014. Vote: Yes, unanimous
- 8.0 Library Director Julie Culp requested that three chairs be purchased to replace three worn public-access computer chairs at the library. Moved Okonuk/Finelli to authorize the expenditure of up to \$200 for the purchase of three chairs for use by the public at the Jonathan Trumbull Library, funds to come from TIP Account #208-00-620-6200 Vote: Yes, unanimous
- 9.0 To correct an icing problem in the area of the portico at the Senior Center, John Dudek recommends the installation of gutters along the portico roof edges to collect and move water off the sidewalk. Motion Finelli/Bendoraitis to authorize the purchase and installation of gutters at the Senior Center, in the amount of \$645.00 funds to come from TIP Account #208-00-510-5100. Vote: Yes, unanimous
