SPECIAL MEETING
May 21, 2013 – 4:00 PM
Town Hall
MINUTES

- 1.0 First Selectman Joyce Okonuk called the meeting to order at 4:05 pm. Selectmen Linda Finelli and John Bendoraitis, and Administrative Assistant Patti Handy were also present. Audience: 1.
- 2.0 Recreation Coordinator Sandra Tremblay was present to request that the Selectmen approve the cost for repairing, painting and refilling the Town Pool. Tremblay explained that she had obtained a price of \$4,041.42 from Savol Pool Company of Windsor, CT for draining, sandblasting and painting the pool and repairing several tiles around the edges. The Town has worked with Savol Pool for many years and has always been satisfied with the quality of their services. Tremblay also had obtained the following prices for refilling the pool:
- Kleen Water Company: \$2,600.00
 - Irish Spring Water Company: \$2,500.00 (paid at delivery).
- Okonuk recommended that the Town pay for the draining and repairs from the TIP account and the Recreation Commission pay for the cost to refill from their revenue account. Tremblay agreed. **Motion made by Okonuk, seconded by Finelli to approve the bill for \$4,041.42 to Savol Pool Company of Windsor, CT for the draining, sandblasting, and tile repair at the Community Center pool, funds to come from TIP Acct. #208-00-510-5100. Vote: Yes, unanimous.** It was noted that the Recreation Commission will pay \$2,500.00 to Irish Spring Water Company from their revenue account.
- 3.0 Tremblay, on behalf of the Rec Commission, requested approval to hire/rehire summer staff for the Town Pool as recommended by the Recreation Commission. She explained that most of the staff are returning from previous years and would be paid the same wages as last year until such time as the 2% COLA increase for part-time non-union staff is approved. **Motion made by Bendoraitis, seconded by Finelli to hire one (1) Aquatics Director at \$14.76/hour; three (3) Water Safety Instructors at \$11.08/hour and three (3) Lifeguards at \$10.11/hour. Vote: Yes, unanimous.**
- 4.0 Okonuk explained that she had received a letter of resignation from custodian Richard Chabot 6/30/2013, which is the end of his current contract. Okonuk asked the Selectmen for approval to go out to bid for janitorial services for Town buildings. **Motion made by Finelli, seconded by Bendoraitis to authorize the First Selectman to solicit bids for janitorial services for the Town Hall, Community Center and Fire Safety Complex. Vote: Yes, unanimous.**
- 5.0 **Motion made by Finelli, seconded by Okonuk to adjourn at 4:20 pm. Vote: Yes, unanimous.**
