- J. Bendoraitis requested that Item 4.3A be removed from the Consent Agenda, citing the need to amend the Minutes of the February 5, 2019 regular meeting. B. Dennler noted that since this is a special meeting, items cannot be added to the agenda. Therefore, approval of these minutes would have to wait until the April Regular Meeting.
- B. Petrie struck Item 4.3A from the Consent Agenda. J. Bendoraitis MOVED to approve the Consent Agenda as amended. B. Petrie SECONDED.

5.0 New Business

Discuss and act upon:

5.1 Review of performance and goals with Building Official

B. Petrie noted that since this was a personnel discussion that the Building Official could request this be done in Executive Session. J. Nowosad declined and said it was okay to do in public session.

- J. Nowosad discussed revenue for the Building Department since he was appointed in 2015 and noted that there has been an increase in inspections over the course of his term. In FY 15/16 there were 876 inspections. In FY 16/17 there were 1005 inspections. In FY 17/18 there were 954 inspections. So far in FY 18/19 there have been 578 inspections. He said he has redeveloped the applications and extended days and hours of service.
- J. Bendoraitis asked about how the department monitors permit times. J. Nowosad said they issue notices about permit expirations quarterly now. B. Petrie said the department needs to come up with a better software system instead of relying on an in-house system. J. Nowosad mentioned the possibility of ViewPermit but both he and J. Bendoraitis agreed that it does not appear to be inexpensive. He said it would allow people to pull permits online.
- B. Petrie also stated the job description currently used for the Building Official is out of date and should be updated.

NO ACTION TAKEN

- Following the review, the Selectmen considered whether to reappoint the Building Official before his term expires in June. B. Petrie said the Building Official is appointed for four-year terms.
- B. Petrie MOVED to reappoint Jason Nowosad as Building Official, effective June 11, 2019, with a term to expire on June 11, 2023. J. Bendoraitis SECONDED.

5.3 Quote for work on Community Center ramp

- J. Nowosad provided a quote from Regan Renovations for work on the Community Center ramp which he said was in need of repairs. The quote was for \$1,680.00 but included the cost of labor only. He estimated the cost of materials at \$3,525.28. Combined, this would cost less than the \$6,000.00 budgeted for this project under TIP.
- B. Petrie MOVED to authorize up to \$5,500.00 from TIP for repairs to the Community Center ramp including work by Regan Renovations. J. Bendoraitis SECONDED.

5.4 Quote for work on exterior lighting upgrade at Community Center

- J. Nowosad provided a quote from Professional Electric for the replacement of lighting at the Community Center. He said this includes converting to LEDs and a computerized system for exterior lighting. He noted it would need Wi-Fi access. It also includes the installation of a motion sensor LED unit for the electrical panel room at the Community Center.
- B. Petrie MOVED to authorize up to \$3,250.00 from TIP for work on an exterior lighting improvement project at the Community Center by Professional Electric. J. Bendoraitis SECONDED.

- 5.5 Quote for work on exterior lighting upgrade for Town Hall

- J. Nowosad provided a quote from Professional Electric for the replacement of exterior lighting at Town Hall which includes a system that would utilize the Town Hall's existing Wi-Fi network.
- B. Petrie MOVED to authorize up to \$4,000.00 from TIP for work on an exterior lighting improvement project at the Town Hall by Professional Electric. J. Bendoraitis SECONDED.

5.6 Potential questions for upcoming POCD survey

Town Planner P. Chester presented a question that would gauge resident interest in curbside trash pickup. He noted there have been complaints from residents over the years about individuals who opt not to do garbage pickup and whose trash ends up laying around. If the Town contracted with a provider, it could potentially secure a lower rate for residents who already get curbside pickup and would ensure that all trash in town is being picked up. The Transfer Station would still remain open.

He said there is no harm in using the POCD survey to ask residents how they feel about the subject. It would give the Board of Selectmen information on whether there is interest and support for such a concept in Lebanon.

B. Petrie MOVED to recommend to the Planning and Zoning Commission to ask the following question on the upcoming POCD resident survey: "Would you favor or oppose the town coordinating with a curbside trash provider to assure that all town residents' trash and recycling is accommodated for and paid for through local taxes? If opposed, why do you oppose the town coordinating residential trash pickup?" J. Bendoraitis SECONDED.

- 5.7 Authorize the sale of all Kraft Heinz shares from the Town Endowment fund

 The Board of Selectmen reviewed a memo from Edward Jones which manages the Town
 Endowment fund. The memo stated Kraft Heinz had been downgraded to a Sell from a Buy, citing
 weak earnings, an investigation into the company's accounting practices, management's lack of
 credibility, and a low-growth outlook.
- J. Bendoraitis MOVED to sell all shares of Kraft Heinz and to invest the proceeds in Franklin U.S Government Securities. B. Petrie SECONDED.

5.8 Town computer software upgrade proposal from Novus

B. Petrie stated that she had contacted Novus, the Town's IT contractor, to evaluate which computers need to be upgraded to new software. She said Novus had already performed an inventory and evaluation of computers owned by the Town. B. Dennler mentioned that many computers are running outdated versions of Windows which could present a security concern in the long term as operating systems and browsers become unsupported. The Novus proposal would upgrade all Town computers to Windows 10.

B. Petrie MOVED to authorize the First Selectman to sign a contract in the amount of with Novus, in the amount of \$3,400.00 with funds to come from TIP, to upgrade all Town computers to Windows 10. J. Bendoraitis SECONDED.

5.9 Possible redesign and upgrades to Town website

- B. Dennler discussed his concerns about the current Town website. He said the existing site is visually outdated and cluttered, making information difficult to find for residents. He said for a long time there appears to have been a habit of posting information that could have been hosted on a subpage or hidden page by scanning and posting PDFs. The site is cluttered with these PDFs which are not easily searchable. He also described his concerns regarding technical issues on the administrator's end of the website, including problems with posting documents, editing text, and posting meetings, minutes, and agendas.
- B. Dennler said there are two approaches the town could take. It could upgrade the existing site with its current provider. He noted Sprague has done this recently and it has modernized the appearance of their website. The other option is to move to a new provider with a larger staff. J. Bendoraitis expressed that he likes to contract with smaller local businesses when possible but acknowledged there are advantages to having a larger provider that can escalate things further when there is a technical issue.
- J. Bendoraitis suggested that if the Town does go forward with a redesign of the website, they should put together a working group so developing the site plan does not fall entirely on one person.

5.10 Proposal from CivicPlus for municipal website design and hosting

- B. Dennler said he had been in contact with CivicPlus, a major provider of municipal websites, about the possibility of a redesign for Lebanon. He noted that the cost is higher than the current service but would be much more responsive and capable than the existing site. He shared the CivicPlus proposal which includes \$10,000.00 for the design of the site plus an annual service fee of \$2,500.00. He also shared links to several towns in the area including Franklin, Colchester, and Norwich that have recently upgraded their sites through CivicPlus. He noted that Lebanon's site would not necessarily have to follow these designs.
- B. Petrie and J. Bendoraitis indicated they were interested in moving forward but had more questions they would like answered first. B. Dennler said he would set up a conference call with a CivicPlus representative and J. Bendoraitis said he would participate.

6.2 Department of Public Works garage proposal

R. Cady and J. Tuttle discussed sites for the possible Public Works garage and salt shed with the Board of Selectmen. These sites included the property near the schools which was the proposed location for the failed referendum in November and the properties at the transfer station and the fire department. The discussion focused largely on the property and plans if they were to move forward with the project at the fire department location which is across the street from the existing facility. B. Petrie and J. Bendoraitis asked for clarification on whether the plans have an appropriate buffer between the facility and any wetlands. R. Cady said that they do and reviewed site plans with the Selectmen. They also discussed including a shared wash bay for use with the Fire Department and possibly Senior Center vans if the building was constructed behind the Lebanon Volunteer Fire Department.

B. Petrie said they would need to go before the Planning and Zoning Commission for an 8-24 before the project can go forward. She said she would like to get the project on the agenda for the Annual Town Meeting in May. She recommended the Public Works Building Committee bring their new proposal before the Inland Wetlands Commission to get final approval for the project to be built at that site.
