## **REVISED ORDINANCE FOR MUNICIPAL BUILDING PERMIT FEES**

## FOR THE BUILDING DEPARTMENT IN THE TOWN OF LEBANON

BE IT ENACTED by the Town of Lebanon at a duly warned Town Meeting to be held on the 20<sup>th</sup> day of June 2016.

The ordinance entitled "REVISED ORDINANCE FOR MUNICIPAL BUILDING PERMIT FEES FOR THE BUILDING DEPARTMENT IN THE TOWN OF LEBANON", dated October 1, 2012, is hereby repealed and replaced with the following:

Fees for the following permits: fees will be calculated at \$12.00 per thousand dollars of value. Valuations shall be subject to review per Connecticut Building Code Section 108.3

BUILDING PERMITS:	New Residential, Commercial, Additions, Garages, Barns. Value calculated using most recent per square foot costs labor and materials as published by the International Coc Council. Includes cost for trades permits, tradesmen requ file permits.	le
Pole Barns:	Pier or no foundation, no floor, not including trades permits. Value calculated at \$15.00 per square per square foot.	
Trades:	Electrical, Plumbing, and HVAC. Fair market value for labor and materials.	
Basement/Bonus Room Finishing:	Value calculated at \$40.00 per square foot – not including trades permits.	
Repairs/Renovations/ Window Replacement:	Fair market value for labor and materials.	
Re-Roofing/Re-Siding:	Value calculated at \$350.00 per square (100 square feet).	
Pools:	Fair market value for labor and materials.	
Decks/Porches:	Value calculated at \$30.00 per square foot-not including trades permits.	
Demolition Permit:	Fair market value for labor and materials (\$3,000.00 minimum).	
Minimum Permit Fee:	For all types of building permits.	\$35.00

Fees for the following permits are flat fees or fees calculated with another formula, as follows:

	Non-refundable. Also subject to bond per Town Ordinance.	\$50.00

	Non-refundable portion of all permits requiring plan review.	\$150.00

Building Permit Fee Waiver:			
	The Board of Selectmen is authorized to consider and act upon waiving or reducing town building permit fees for projects identified in Lebanon's Plan of Conservation and Development. Single-family or detached two-family dwellings		

This ordinance shall take effect fifteen (15) days after publication in accordance with the Connecticut General Statutes.
