Dan Moore reported that asphalt shingles were used on the Exeter Hearse House for a cost of \$4250.00 and he hopes to have the gate repaired soon by a welder. Both Kozikowski men exited the meeting at 6:43 P.M. Motion by Jim, seconded by Shaun to have Dan get 3 pine trees at Prides at a cost of \$115.20 for North Lebanon Cemetery, passed unanimously. The First Selectman exited the meeting at 6:45 P.M. and Hunter Sanchez and his mother exited at 6:47 P.M. Discussion about possibility of donation of stones from a demolished building to be used in building 100 ft. of wall in North Lebanon Cemetery. Motion by Dan Moore, seconded by Jim Barrett, to approve the minutes of the July Meeting, passed unanimously. The Chairman proclaimed the meeting adjourned at 7:32 P.M.
