## Assessment and Conservation Survey

## Methodology

The Siena College Research Institute used a listed sample to call residents in the Town of Lebanon from April 15 – May 6, 2019. Three hundred and thirty- three (333) people completed the survey. The study has a margin of error of +/-5.4 percentage points.

The survey instrument has both close ended and open ended questions. The cross tabulations for the data can be found in Appendix 1 and the verbatim from the open ended questions can be found in Appendix 2.

Below is the nature of the sample:

The strongest support but still only a plurality was for offering tax incentives such as a reduction in property taxes to developers to develop senior housing (49% support/44% oppose). With those over 55 years old supporting the initiative at a 52%/40% rate.

The allocation of up to \$250,000 to construct multi-purpose recreation fields at Aspinall Recreation Complex was evenly split at forty-five percent (45%) to forty-five-percent (45%). The biggest difference in the demographics was found in the age group. Fifty-five and under supported this at fifty-eight (58%) while the fifty-five plus group only supported it at thirty-six (36%).

Support fell for the town to use local taxes to coordinate with a curbside trash provider for residential trash and recycling 38% to 55%. There were differences within the demographic variables with more females supporting this idea.

The least amount of support was given to the idea of offering tax incentives to promote economic development and/or multi-family housing at Exit 22 with only twenty-eight percent (28%) of the respondents supporting it.

When asked about other recreational activities that the respondents would like to see added to the town, water activities were mentioned the most. Including extending the hours of the swimming pool, adding an additional pool, and creating public beach access. One respondent left provided a lengthy message;

“I would like to have a multi-sports complex in town such as the Mansfield community center where **families can go to swim (big pool to swim laps)**, lift weights, run on an indoor track, partake in fitness classes, dance classes and do arts and crafts. I would love for the town to partially fund the facility and for citizens to pay a membership cost. **We could open up the two small lakes to have a beach that has public access.** There would need to be parking added. There could be something science-related (besides Legos) for people who are not sports-oriented. The science-related activities should be more geared toward middle school and high school students. I would like to have the ability to use open space for hiking and mountain biking purposes.”

Paths and trails were the next most mentioned recreational activity to add including more biking and hiking trails.

Activities for youth, additional sports activities and activities for adults were mentioned. (For all verbatim see Appendix 2.)

The last question was which one of the following five choices should be the main focus of the Town of Lebanon’s planning efforts over the next ten years and by far respondents said the focus should be on preserving farmland and open space (52%). Focusing on commercial development was second to that at eighteen percent (18%).


## Findings:

When asked, "What do you think the most import issue is facing Lebanon today?" twenty-percent (20%) said high taxes and sixteen percent (16%) said school and education issues.

Almost everyone, ninety-four percent (94%) said that it is somewhat or very important that the town have working farms and open space and similarly eight-seven percent (87%) said that the town should continue to fund farmland and open-space preservation. When asked if the town should continue to fund the preservation of working farms and open space sixty-four percent (64%) said it was very important. Of those who said the town should *not* fund working farms and open space (36 people) sixty-five percent (65%) of those (23 people) said that it was very to somewhat important to them to not fund the working farms and open space. Twenty-two percent (22%) said it was not too or not at all important to them.

The respondents were asked their support for or opposition to several possible initiatives.
