- I. The meeting was called to order at 7:00 p.m. by Chairman McCaw.
- II. Acceptance of Minutes:

Mr. Hallene made a motion to approve the April 2, 2012, Regular Meeting Minutes, seconded by Mr. Drum. Members voted unanimously to approve the minutes as presented.

III. <u>New Business</u>:

a. **#IW-12-1237**: 6 Deepwood Drive, Assessors Map 103, Lot 95. Joyce Clark, owner, Brett Hallow, BSA Landscaping, applicant. Yard drain and pipe.

Mr. Hallow and Mr. Mikowski (owner's husband) were present on behalf of the owner stating this request is to relieve basement flooding. The application is to drain a wetland/retention depression on the site by installing a drain pipe which will lead to the end of the property line onto Mr. Connor's (neighbor's) property and then into Amston Lake. Mr. Connor, the neighbor has submitted permission to the town to allow drainage onto his property.

b. **#IW-AR-12-1253**: 894 Exeter Road, Assessors Map 245, Lot 18. Lincoln Chesmer, owner. Clearing for cropland and improvements to wetland crossings.

Request is to clear the opposite side of stream that is overgrown and minimum improvements to two crossings with gravel and stone material. NRCS has flagged wetlands.

c. **#IW-12-1262**: 220 Norwich Avenue, Assessors Map 275, Lot 39. Trevor A. Foster, owner. Excavation for pond construction.

Mr. Zemba, Soil Scientist, GZA, reviewed the proposed mitigation report.

d. 110 Clarke Road, Assessors Map 222, Lot 27. Ken Perry, owner.

Mr. Perry addressed the Commission to request that his conservation easement be changed to allow him to expand his pond and place the fill on land abutting his new home in the conservation easement area. No action taken.
