II. Acceptance of Minutes:

a. Jim Hallene made a motion, seconded by John Drum, to approve the April 7, 2014 Regular Meeting Minutes as presented. Motion unanimously approved. Abstained: Robert Slate.

III. Old Business

John Drum recused himself for the show cause hearings and left the meeting room.

a. NOTICE OF VIOLATION ~ Nicholas Gebbie, for property at 590 Tobacco Street, Assessors Map 224, Lots 2.011, 5 and 7-9.

The Commission determined that the Notice of Violation issued to Nicholas Gebbie should remain in effect.

b. <u>NOTICE OF VIOLATION ~ Ronald and Barbara Drum, owners, 590</u> Tobacco Street, Assessors Map 224, Lots 2.011, 5 and 7-9.

Wes Wentworth, Wentworth Civil Engineers spoke on behalf of the owners who we also present. Walking the site and using satellite images and previously filed area maps of delineated wetlands, Mr. Wentworth created a current map of the approximate wetland areas affected. He gave recommendations for correction and stabilization and a remediation plan will be submitted for the next meeting. The Commission accepted Mr. & Mrs. Drum's wetlands application and this item will be placed on next month's meeting agenda.

c. **IW-AR-14-3392:** Goshen Hill Road (North side), Assessors Map 246, Lot 43, Susan and Arthur Duhaime, owners. Clearing for farmland. Wes Wentworth spoke on behalf of the owners who were also present. Clearing of brush is along edge of wetlands only.

Jim Hallene made a motion, seconded by Dennis Latchum to approve the application. Motion unanimously approved.

d. **IW-14-3393:** Goshen Hill Road (North side), Assessors Map 246, Lot 43, Susan and Arthur Duhaime, owners. Crossing for driveway and construction of single family dwelling in regulated area.

Jim Hallene made a motion, seconded by Robert Slate, to approve the application. Motion unanimously approved.
