- 1.0 The meeting was called to order at 4:19 pm.
- 2.0 Minutes. Discuss and act on:
- 2.1 (Smith/McCaw) made a motion to approve the Minutes of the April 25, 2017 Regular meeting as presented. All approved unanimously.

- 3.1 No reports received from the Finance Dept/Town of Lebanon Budget was not approved by town in May.
- 3.2 (McCaw/Moore) made a motion to pay West River Restoration and the balance of \$3075.00 as quoted for completion of basement hatchway, stairs and windows to come from the balance left in Adams Memorial Fund Grant Phase III administered by the Lebanon Historical Society. All approved unanimously.

- 3.5 Status of display cases: Installation is required. Members of Board to consider.

- 4.1 (McCaw/Smith) made a motion to reimburse Sherri-Ann Martin a total of \$ 68.44 for purchase of a surge protector (\$18.07), Wine (\$23.41) and Crackers, cheese and tablecloths (\$26.96) for Robert Hubbard book talk on June 6, 2017. (McCaw/Smith) made a motion to reimburse Sherri-Ann Martin \$ 119.10 for the purchase of printer ink for Jr. House printer. Payment to come from the Office Supply Account administered by the Town of Lebanon. Acct 215-00-015-5210-0000. All approved unanimously.

4.2 (McCaw/Smith) made a motion to pay the Lebanon Historical Society \$ 130.00 for creation and printing of the Lebanon Revolutionary Brochure. Payment to come from the Adams Memorial Fund Grant Phase IV administered by the Lebanon Historical Society. All approved unanimously.
