4.0 Continue Discussion with Design Team related to Schematic Design Phase of proposed Additions and Renovations

J. Culp reported that application for a Category #1 Project was submitted on August 30, 2013 to the State Grant Program for Public Library Construction. Category #1 Projects are those projects which create additional usable library space, such as new buildings, additions, and renovations. She reviewed the materials that were required to be included with this application which were compiled by collaborative work with the architect, J. Willerup. Action is expected by November 25, 2013.

Susan Cormier, State of Connecticut Library Services Consultant for Children's Services, met with J. Culp and L. Slate, Library staff, to discuss the plans that had been submitted. Her role is to make suggestions and recommendations regarding these plans. Recommendations will be forthcoming in written form. When these are received, the design subcommittee may need to meet.

J. Willerup reviewed the latest schematic drawings. The next step is to develop the budget for the project. He will provide the preliminary figures electronically for submittal with additional grant applications. The timeline for the project was reviewed. Design Review Board approval needs to the added.
