- Modify windows to more standard design
- Modify South side of building plan to eliminate "bump-out"
- Modify West side of building to slab on grade rather than full foundation
- Modify parking area to include only required spaces appropriate for square footage of building
- Eliminate walkways around building
- Downscale landscaping around relocated monument in parking area
- Eliminate interior architectural columns
- Rework/reduce circulation desk areas (upper and lower floors)
- Re-examine program to possibly reduce square footage
