## I. CALL TO ORDER

The meeting was called to order by Commission secretary R. Chesmer at 7:00 p.m. He appointed E. Stearns as a voting member.

#### II. OLD BUSINESS - none

#### III. NEW BUSINESS

a. PZ-23-6: 217 Card Street, Assessor Map 202, Lot 53. Request for special permit for 32' x 30' accessory storage building per Zoning Sec. 7.3(b). Set public hearing date.

Chester gave updates on the 98-acre Stearns Farm preservation project which was completed this month; the 104-acre Andrews Farm preservation project which should be completed in the spring; a building permit should be issued for Gan Aden II (8 market rate senior housing units on Doctor Manning Drive) this spring; and planning for upcoming farmers market which begins June 3<sup>rd</sup> is well underway and that there will be several new vendors and a Lebanon farm winery day added to the list of special events.
