Mr. LaPorte made a motion to add discussion and action on Dennis Wengloski, Earth Excavation Operation, Goshen Hill Road, Assessors Map 259, Lot 28 under Old Business. Seconded by Mr. Malozzi and unanimously approved.

In the fall of 2015 the Commission conducted a site visit of the former Den's Sand and Gravel operation on Goshen Hill Road and subsequently voted to accept a \$10,000 bond from Dennis Wengloski with the understanding that no further work be conducted on the site with the exception of work to close the site within a year.

Last month Mr. Chester contacted Mr. Wengloski and reports that the owner was not able to work on closing the operation due to health reasons and that he planned extend his bond for one year. Mr. LaPorte made a motion to grant a one year extension to close the earth excavation operation, formerly known as Den's Sand and Gravel on Goshen Hill Road, Assessors Map 259, Lot 28, subject to a \$10,000 bond renewal in favor of the Town and the understating that the Commission will consider calling the bond if substantial progress in closing the site is not evident next year. Seconded by Mr. Malozzi and unanimously approved.
