I. The meeting was called to order at 7:00 p.m. by Mr. Jahoda.

II. APPROVAL OF MINUTES

a. PZ-17-6502: Dawn and Kevin Whitcher, applicants, 894 Exeter Road LLC, owner, 94 Exeter Road, Assessors Map 245, Lot 18. Special Permit request for restaurant per Zoning Sec. 4.5.d.2).

Motion by Mr. Budney, seconded by Ms. Smith, to approve PZ-17-6502 subject to CT DPH approval of the public water supply system and DOT approval of the new curb cut, and with the understanding that the property abuts active farmland and the town has a Right-to-Farm Ordinance. Motion unanimously approved.
