Redeemer Lutheran Church. Request for site plan modification.

Pastor Scott Schuett described their request to relocate the existing church (328 Village Hill) to the lot across the street (321 Village Hill). Tentative plans for the vacant site, once the church has been moved, are for a memorial garden. Wesley Wentworth, Wentworth Civil Engineers, reviewed the preliminary site plan and said the final site plan would be completed within a week.
