1.1 Call to Order: 6:38 P.M.

1.2 Reading and Acceptance of Minutes of September 13, 2010 Meeting

3.1 Correspondence Received:

Donna has received an e-mail from Cheryl Hutchings of Columbia. She and three other women, walking on section 1 with their dogs, were harassed by 4 dirt bikers. They tried to contact the State Police but no one came. Later one of them went to the Colchester Barracks and were told to get out of the dirt bikers way. Donna had given Cheryl our Resident State Trooper's number and the DEP Enforcement number.

Donna e-mailed our Resident Trooper and attached Cheryl's e-mail. She has not received any reply at this point.

Donna also e-mailed Edith Prague requesting more legislation to deal with this problem. A response from an aide came back indicating they would consider addressing this in the next session.

3.2 Contact with Mark Paquette:

Nusie had contacted Mark Paquette of WINCOG about putting some type of barrier that would prevent ATVs and Dirt Bikes from entering the trail over the bridge, when it has been completed. She has not had a response to her e-mail.

3.3 Barrier Moved at Chesbro:

Walt reported that the large rock which had prevented ATV entrance to section 2 has been pushed aside. It would have taken a tractor or truck to do this. This one more of the very annoying things that have been continuing on the trail.

3.4 Need for new Alternate Member:

Donna will speak to Joyce about advertising for a member for our vacant alternate position. Because of other commitments, many of our members are having difficulty attending the meetings. This is causing a problem with our ability to have a quorum present to conduct business.
