## 1.0 Opening Business

1.1 Call to Order: 6:35 PM

1.2 Reading and Acceptance of Minutes of January 12, 2008:

### 2.0 Old Business

2.1 Status of grants:

We have not received any information concerning the pending grant. We expect to hear by the end of the month.

2.2 Status of spending/ reimbursement of grant money:

The committee discussed what improvements needed to be made to sections 3 & 4. It was decided that we should contact Tom to see how much the town would be able to do for us. We would need exact projects and a timetable. After this is determined, we could write our RFP for theses two sections.

Donna will contact and meet with Tom to get in writing what exactly the town can do for us and when it will be done.

## 2.5 Bridge at Village Hill Road:

Naomi has spoken to Brian Ross of the DEP. He has indicated that their staff will put the railings in at Village Hill Rd. as well as stabilizing the gravel under the bridge.
