A. The meeting was **called to order** at 7:01 PM. Attending: Nick Poppiti (chair), Bob Gentes (Treasurer), Susan Smith (Secretary), Sandra Tremblay, Alan Dunnack, Alexis Hussey, Haley McCall and Laura Davidson. Absent: Aline Soulor. Guests: Phil Chester (Town Planner), Chris Frank, Jen Warner and Jim Powers.

B. **Motion** by Laura Davidson 2<sup>nd</sup> Bob Gentes, to accept the minutes for July 23, 2018. **Motion passed unanimously.**

D. **Public Forum** – Chris Frank and Jen Warner, representing Lebanon soccer club, voiced concerns about a possible soccer shots program for Lebanon.

F. **Recreation Coordinator's Report** - Sandra Tremblay reported on rototilling at Aspinall and Tyler Field to be done by Bill Johnson. Sandra also discussed the removal and replacement of a new foul pole on field one.
