The Selectmen reviewed the preliminary year-end reports. H. Wagner projected a surplus between \$400k and \$500k. She said they expect a smaller surplus on the school budget.

J. Schall reported there were 75 calls in July. The department also hosted rapid intervention training. They are partnering with Bozrah to establish an additional RIT team.

### 7.1 Authorize First Selectman to sign Novus agreement for hosting and cloud services

B. Dennler and R. DelMastro presented a proposal for hosting and cloud services to be provided by Novus Insight. The proposal included the removal of the Town Hall server and migration of server data to Novus which is currently responsible for backing up the existing server which at the end of its life and either needs to be replaced or its services migrated to the cloud. The one-time migration cost was \$12,020. The Town currently pays \$185 per month for backup services. These would be replaced by a \$116 per month fee for a hosted domain controller server, \$34 per month for SQL server licenses, and \$14 per month for CT Municipal Cloud CRCOG services. QDS, the Tax/Assessor department software, can be hosted for \$2,784 per year; IQS, the new Town Clerk software, can be hosted for \$3,900 per year. B. Dennler said the current server would not be able to support the Town Clerk's IQS software which is supposed to go live this month when the office transitions away from Cott.

The Selectmen discussed whether to pay for costs from ARPA or TIP and how to handle the recurring costs. B. Dennler said the Town Clerk can absorb the year one costs of hosting her software under the historic documents grant but she would prefer it be budgeted in the next fiscal year. He said remaining costs could be part of an ARPA allocation to pay for migration and year one operating costs. B. Petrie said she would rather see migration costs to replace the server paid for with TIP and for the recurring expenses to be charged to Account 415 Computer Services. She said that may mean the account is over expended in FY22-23 but they can budget accordingly for the next fiscal year.

*B. Petrie MOVED to authorize the First Selectman to sign Novus agreement for hosting and cloud services and for recurring costs to be paid for with Account 415 Computer Services. K. Cwikla SECONDED.* <u>MOTION CARRIED 5:0</u>

B. Petrie MOVED to recommend that the Board of Finance approve \$12,020 from TIP to pay for the migration of the Town Hall server to cloud hosted services by Novus Insight. M. DeCaprio SECONDED. <u>MOTION CARRIED 5:0</u>

### 7.2 Award of Revaluation Services Contract

E. Sousa reported results of the revaluation services RFP. Municipal Valuation Services bid \$160,000. Vision Government Solutions bid \$75,000. E. Sousa recommended the town award the contract to Vision with an additional \$25,000.

*B. Petrie MOVED to authorize the First Selectman to sign a contract for \$100,000 with Vision Government Solutions for revaluation services. K. Smith SECONDED.* <u>MOTION CARRIED 5:0</u>

### 7.3 Authorize \$7200 from TIP for clearing brush at Exeter Cemetery

### A Proclamation By the Lebanon Board of Selectmen

₩hereas:	September 11, 2022 marks the 100th Anniversary of the opening of the George W. Lyman Memorial High School; and,
₩hereas:	In an extraordinary gesture, upon the December 1919 death of George W. Lyman, he left a major share of his estate to the Town of Lebanon to build a high school. Lyman's bequest of \$15,000 towards construction and \$36,700 for maintenance was accepted by a town vote of 180-16 on October 4, 1920. In accordance with a clause in Lyman's will, the school was to be named after him; classes began September 11, 1922; and,
₩hereas:	After two previous referendums to build a new Junior-Senior High School failed, it was in the third on June 2, 1958, that a \$595,000 appropriation for the new school with a gymnasium was approved. The school on Route 207 opened in September 1959 (now the Lebanon Middle School). A Regional Vocational Agriculture Center was approved in 1961; and,
Whereas:	Again, the student population outgrew the existing building and on December 15, 1988, Lebanon voters approved construction of a new \$18.25 million high school, marking the end of a nearly twenty-year effort to expand existing school facilities and help relieve cramped classrooms. The new high school at 917 Exeter Road opened in 1992; and,
₩hereas:	Now at its third location and in its third building, Lyman Memorial High School still carries the name of the man who had no children of his own but left his fortune to benefit all the children of his hometown; and,
₩hereas:	Lebanon's commitment to fulfilling and maintaining George Lyman's legacy for one hundred years places the town in an elite group of Connecticut communities able to maintain a local education system. Graduates often comment 'We knew everyone in the school,' adding that the subsequent strong bonds often lead alumni to stay in the area, an observation that speaks to the advantages of community-based education emphasized in Lebanon and the Lyman Memorial High School''; and, <i>Gummer 2012 Provision</i> Northeast of the Lebanon Risected Society
₩hereas:	In September 2022, alumni, students, staff, administration, and community members will come together to celebrate one hundred years of education at Lyman Memorial High School.
Therefore:	Be it resolved, the Lebanon Board of Selectmen, hereby recognize the history and continuation of Lyman Memorial High School and proclaim the 2022-2023 academic year as the Centennial Anniversary of this educational institution. In witness thereof, we have hereunto set our hands and caused the seal of Lebanon to be affixed this 2nd Day of August 2022.
