Motion (AW/DM) to authorize Ed O'Connell, WPCA Attorney and Mr. Kurt Mailman, PE, of Fuss & O'Neill to transmit Blanket Easement agreement and Colchester Easement agreement to appropriate authorities of both entities was approved unanimously.

Motion (AW/JH) to approve distribution of Grinder Pump Easement agreement as discussed with suggested changes and cover letter was approved unanimously.

Kurt Mailman, PE, of Fuss & O'Neill gave an update of the project. He discussed policy issues, agreements, Rules and Regulations, USDA funding status, and overall project funding budget.
